## HOLE IN ONE INSURANCE RULES

**ELIGIBILITY** – To be eligible for the \$150.00 credit you must be a participating member. That is you must have paid the \$1.00 fee for the current year. Hole in ones scored at other Clubs in the Victoria District will be subject to that club's rules. Glen Meadow's fund will insure you to a maximum of \$75.00 provided your verified score card from any certified club is turned in to the Glen Meadow's Pro Shop.

**DRINK LIMITS** – Each member present in the clubhouse with the winner as host is entitled to one bar drink. Members are requested to limit their requests to regular hiballs or beer. The one drink per member limit is not applicable to the member scoring the hole in one.

**AWARD CONFIRMATION** – A member must play a minimum of nine holes and the score card must be signed by himself, attested by one other member of his playing group and turned in to the Pro Shop when the round is finished. The member will be given a copy of this instruction for his guidance. A hole in one trophy will be awarded to all the current year winners and their names will be inscribed on the clubhouse scroll.

**FINANCIAL ACCOUNTABILITY** – Before leaving the clubhouse the member must sign off the account, the bar is only authorized to provide drinks against the account for the Pro Shop staff who were unable due to work to have a drink with the member. The account will be passed through the office to the Glen Meadows Members Association for payment. The Glen Meadows Members Association does not pay gratuity or anything over \$150.00, so please do not charge either to the account.
